#### **Parkland Bay Speeding Violation Policy**

Definitions:

Vehicle: Motorized and no-motorized vehicles including but not limited to; cars, trucks, vans, motorcycles, golf carts, and low speed electric vehicles.

Homeowner/Resident: A registered vehicle with Parkland Bay which has an associated gate transponder

Gate Transponder: Your sticker for entry into the Gate

Guest/Vendor: Persons entering the Entrance gate to Parkland Bay

Suspension of Gate Transponder: Temporary Deactivation of your Gate Transponder for Gate Entry

**Application of Guidelines** 

These guidelines apply to all vehicles on Parkland Bay Roads and Sidewalks, and violations will be tracked by Parkland Bay Property Management

Speed Cameras

Speed Cameras shall be placed in areas of Parkland Bay and can be moved or changed at any time, without notice. Additionally Mobile (non static) speed cameras may be used within Parkland Bay.

Violations

In the case of Vendors and Guests, the Property Manager shall issue violations to the gate access system registered operator of the vehicle and the responsible Vendor or Guest, as can best be determined by the Property Manager.

If a vehicle is not registered with the gate access system, violations shall be issued to the appropriate persons and entities, as can best be determined by the Property Manager

Parkland Bay Property Management will issue violations to the registered name associated with the License Plate

2nd Offense	\$100 and suspension of gate transponder for 15 days
3rd Offense and beyond	\$100 and suspension of gate transponder for 30 days for the entire household

### 21+ mph over Posted Speed Limit

Offense	Citation/Fine
1st Offense	\$100 and suspension of gate transponder for 15 days
2nd Offense and beyond	\$100 and suspension of gate transponder for 30 days for the entire household

#### Vendors & Guests

### 1-10 mph over Posted Speed Limit

Offense	Citation/Fine
1st Offense	Warning
2nd Offense	\$50
3rd Offense	\$75
4th Offense	\$100
5th Offense and Beyond	\$100 and potential suspension from entry into Parkland Bay

## 11-20 mph over Posted Speed Limit

Offense	Citation/Fine
1st Offense	\$50
2nd Offense	\$75
3rd Offense	\$100
4th Offense and beyond	\$100 and potential suspension from entry into Parkland Bay

### 21+ mph over Posted Speed Limit

Offense	Citation/Fine
1st Offense	\$75
2nd Offense	\$100
3rd Offense and beyond	\$100 and potential suspension from entry into Parkland Bay

Vendors and Guests will be billed directly to the license Plate captured at the Entry Gate

Unpaid fines for Vendors and Guests could result in denied entry into Parkland Bay through the Entry Gate
